






### Pupils years 7-11 said:

Do you think that unwanted sexualised behaviour and peer-on-peer abuse is a problem at our school?









How often do you think pupils in years 9 and above are exposed to peer-onpeer abuse at Comberton Village College and Comberton Sixth Form?

#### Why not report it?





- I feel ashamed.
- I think my friends will drop me if I report it.
- I'm worried about how the adult will react.
- I worried about what will happen after I tell.
- I don't want to cause trouble.
- I don't want people to think
  I'm a snitch.

- I'm worried about what rumours people will spread about me.
- I'm worried that I might get into trouble too, as I did things I shouldn't do too.
- There's no point in reporting it as no one really cares about this, it happens all the time.

## Pupils years 7-11 said:





Who do pupils report unwanted sexualised behaviour to?



Pupils have **NOT** told an adult about this, because:

Not considered serious enough

Nothing would come of reporting it

Not comfortable talking to an adult

This is representative of what Sixth Form students reported.

## Whole School, Sixth Form Approach





All settings should take a whole - establishment approach to keeping children safe.

They should set expectations that violence and harassment of any kind will not be tolerated, support children to have a good understanding of consent and healthy relationships and provide immediate support for victims of abuse.

# Ofsted Rapid Review of Sexual Abuse in Schools and Colleges (June2021)



'It is concerning that for some children, incidents are so commonplace that they see no point in reporting them... It recommends that schools, colleges and multi-agency partners act as though sexual harassment and online sexual abuse are happening, even when there are no specific reports.'

#### Definition





Sexual harassment is unwanted behaviour of a sexual nature which:

- violates someone's dignity
- makes someone feel intimidated, degraded or humiliated
- creates a hostile, offensive or sexualised environment

# Sexual harassment can include:





- sexual comments or jokes
- physical behaviour, including unwanted sexual advances, touching and various forms of sexual assault
- sharing nude pictures/videos (nudes)
- sharing unwanted explicit content
- upskirting
- unwanted sexual comments and messages

#### What have we done?





- Surveyed students and parents to understand their views and experiences of sexual harassment and peer-on-peer abuse in school
- Surveyed staff to gain a deeper insight into school culture and behaviours around sexual harassment
- Discussed findings of survey at senior leadership and middle leadership level
- Given assemblies to students on the findings of the survey and what they can do to support a culture in the school which reduces cases of sexual harassment
- Held student focus group
- Started training for ALL staff on how to reduce sexual harassment/peer-on-peer abuse
- Bus driver training
- Developed safer corridors logs for Go4Schools
- Developed sanction ladder for all staff to refer to and action
- Parent focus group

#### What are we doing next?





- Looking at strategies for students to report abuse and concerns more easily
- Training/information evening for parents looking supporting young people with sexual behaviours
- Assemblies for pupils/students years 7 13 (Termly)
- Tutor led activities in tutor groups (September)
- Another survey to measure progress
- Consider amendments to curriculum.
- Formulating a peer-on-peer abuse policy
